Meeting Notes

Approval of meeting summary

The June 25th meeting notes were approved as amended. The July 23rd and August 27th meeting notes were approved as written.

Open Session

There were no members of the public wishing to speak.

Planning Commission Meeting

A committee member asked for an update on the results of the Planning Commission (PC) meeting regarding the Comprehensive Plan and Zoning code amendments affecting the surface mining regulations and Mineral Resource Lands (MRL) designation and policies. One of the committee members who was present at the meeting stated that the PC seemed surprised that the Surface Mining Advisory Committee (SMAC) would recommend changing the permitting process from Administrative Approval to Conditional Use. The committee members discussed their reasons for supporting the change and will provide their rationale to Scott Hulse (SMAC member) so he can prepare a White Paper to provide to the PC at their next meeting.

Chapter 8 Comprehensive Plan

Staff and the committee reviewed the goals and policies of the mineral resources portion of the comprehensive plan. The committee discussed the goals and policies individually to determine if there were necessary changes. The committee discussed Goals 8Q and 8R and their associated policies. The committee began to discuss the MRL Designation Criteria but were unable to finish.

Dismissal

Prior to dismissal, the committee discussed meeting dates through the end of the year. The October 22nd meeting will begin at 2pm instead of 3pm, in order to receive an update on the Aggregate Resource Inventory Study Update from Element Solutions. The regularly scheduled November and December meeting dates would fall on Thanksgiving Eve and Christmas Eve, respectively, so the meeting dates were moved to the Monday of those weeks.
